A complaint letter received from M.P.Ed. II year student Mr. Steve Rayman C, stated that as he was in sleep at 12:30 a.m., on 17th April 2023, his classmate Mr. Dinesh B went to his room with liquor and drank fully and asked him to go outside. As he refused to go out, Mr. Dinesh scolded him and his family like anything with abusive and filthy language and assaulted him heavily. Then it was come to the notice of Sub Warden, As the Sub Warden is asked to wait him till the morning, he get back to room with injuries.

In the next morning by 11:30 a.m. again Mr. Dinesh came to his room while he was in sleep and kicked him and squeezed his neck and threw him out from his cot. As he is unable to defend he reported again to the Deputy Warden and the Sub Warden. Further it was came to his notice that, from today (18th April 2023) his SSLC Original Mark statement which was kept under his possession inside the College Hostel has been missed out after this incident. Therefore he requested Principal to take necessary

action against Mr. Dinesh and help him to get back his SSLC Original Mark Statement as he having doubt on Mr. Dinesh.

Further, the Deputy Warden and the Sub Warden recommended to take necessary action in this regard, the Disciplinary Committee decided to suspend Mr. Dinesh B of M.P.Ed., II year (bearing Roll No. 202101028) from 19th April 2023 to 24th April 2023 for four working days since he has indulged in violation of hostel rules consuming alcohol and in man handling with his classmate Mr. Steve Rayman. C of M.P.Ed. II year.

Further, He is instructed to not enter into the College premises during the suspension period and he is directed to report to the Principal on 25th April 2023 along with his parents on completion of suspension period.

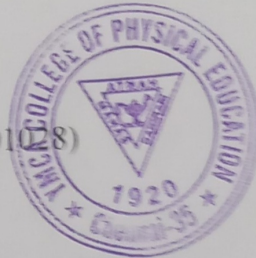
Order:
